ETHICS

The Nexperia Code of Conduct defines the principles and high standards which are applied to its business practices and those of its global supply chain. This Code is enshrined in the contracts of all employees and encourages respectful, dignified and professional standards of behavior across our global network of sites. We expect from our suppliers to act according to our Supplier Code of Conduct and obtain materials from socially responsible and sustainable sources.

LABOR & HUMAN RIGHTS

Respecting and recognizing labor & human rights all over the world is an essential part of Nexperia's business activities. We have formal grievance and remedy mechanisms to enable Nexperia employees to report any concerns and/or violations. The requirements for Nexperia and the entire supply chain are described in our Social Responsibility Management System.

EMPLOYEES

We have a global workforce that is highly diverse, both geographically and culturally. We are committed to providing a workplace that is safe and secure, where every employee is empowered to achieve a healthy work-life balance, and everyone is treated with respect and dignity.

PRODUCTS

We are committed to create the highest quality products and packages. Our products are developed to provide a positive contribution to society. We aim for continuous reduction of environmental impact with each new product generation (following e.g., RoHS / REACH requirements).

OPERATIONS

We pursue the careful use of resources. We employ strategies to optimize energy efficiency and material use, manage the water use and the wastewater we produce, lower greenhouse gas and other significant air emissions, reduce waste, source our materials responsibly and establish plans to phase out critical



hazardous substances. We are analyzing our workplaces to eliminate hazards and reduce EHS risks where needed. Our chemicals management system ensures the safe and environmental compliant use of hazardous substances in our production processes.

COMPLIANCE
